

.xn--fiq228c5hs (.CHINESE WEBSITE) – Terms and Conditions

In addition to your registration agreement, the .CHINESE WEBSITE Registry-Registrar Agreement (“**RRA**”) terms and conditions set out here shall apply. In the event of any inconsistency between the terms of your registration agreement and the terms set out here, the RRA terms shall prevail.

1. Each registered name holder agrees to indemnify, defend and hold harmless TLD Registry and its subcontractors, and the directors, officers, employees, affiliates and agents of each of them, from and against any and all claims, damages, liabilities, costs and expenses, including reasonable legal fees and expenses, arising out of or relating to the registered name holder’s domain name registration. This indemnification obligation shall survive the termination or expiration of the registration agreement.

2. Each registered name holder shall comply with each of the following requirements:
 - a. ICANN standards, policies, procedures, and practices for which TLD Registry has monitoring responsibility in accordance with the registry agreement entered into between TLD Registry and ICANN dated 08 September 2013, as amended from time to time (the “**Registry Agreement**”) or any other arrangement with ICANN; and
 - b. Operational standards, policies, procedures, and practices for the Registry TLD established from time to time by TLD Registry in a non-arbitrary manner and applicable to all registrars, including affiliates of TLD Registry, and consistent with ICANN's standards, policies, procedures, and practices and TLD Registry’s Registry Agreement with ICANN. Additional or revised TLD Registry operational standards, policies, procedures, and practices for the 中文网 (xn--fiq228c5hs) (Dot Chinese Website) TLD shall be effective upon thirty days’ notice by TLD Registry to the registrar. If there is a discrepancy between the terms required by RRA and the terms of the registrar’s registration agreement, the terms of RRA shall supersede those of the registrar’s registration agreement.

3. Each registered name holder:
 - a. consents to the use, copying, distribution, publication, modification and other processing of the registered name holder's personal data by TLD Registry and its designees and agents in a manner consistent with the purposes in the RRA;
 - b. submits to proceedings commenced under ICANN's Uniform Domain Name Dispute Resolution Policy (“**UDRP**”), the Uniform Rapid Suspension (“**URS**”), or any other dispute resolution mechanism imposed by ICANN and/or organized by TLD Registry;
 - c. agrees to immediately correct and update the registration information for the registered name during the registration term for the registered name, including personal data associated therewith;
 - d. agrees to be bound by the terms and conditions of the initial launch of the 在线 (xn--3ds443g) (Dot Chinese Online) TLD, including without limitation the sunrise period and the land rush period, and the sunrise dispute resolution policy, and further to acknowledge that TLD Registry has no liability of any kind for

any loss or liability resulting from the proceedings and processes relating to the sunrise period or the land rush period, including, without limitation: (a) the ability or inability of a registrant to obtain a registered name during these periods, and (b) the results of any dispute over a sunrise registration; and

- e. acknowledges and agrees that TLD Registry reserves the right to deny, cancel or transfer any registration or transaction, or place any domain name(s) on registry lock, hold or similar status, that it deems necessary, in its discretion; (1) to protect the integrity and stability of the registry; (2) to comply with any applicable laws, government rules or requirements, requests of law enforcement, or any dispute resolution process; (3) to avoid any liability, civil or criminal, on the part of TLD Registry, as well as its affiliates, subsidiaries, officers, directors, and employees; (4) per the terms of the registration agreement or (5) to correct mistakes made by TLD Registry or any registrar in connection with a domain name registration. TLD Registry also reserves the right to place upon registry lock, hold or similar status a domain name during resolution of a dispute.
